

## PRIVACY POLICY FOR EMOH-APP

---

**Emoh-app.com** respects user privacy. When you use Emoh mobile application and/or its website platform or Messenger service (hereafter collectively referred to as the “Site”), we collect and use certain information about you and use of the Site so as to improve our Site and services as described in this Privacy Policy.

This Policy explains our approach to online information collection, storage and uses in connection with the Site, as well as the specific choices you can make about your personal information. Please read this Policy carefully. By using the Site you will be deemed to have agreed to this Policy, so if you do not agree please do not use the site.

### 1. Changes to this Policy

We may modify this Policy from time to time and notice of such changes will be posted on the Site so do review it regularly. This Policy was last updated on 22 October, 2017. ### 2. Information Collection

We do not collect personally identifiable information about you, for example, your name, address, telephone number, e-mail, etc., unless you choose to complete and submit a registration application to us or if you contact us directly. You should be aware that you may be making available personally identifiable information about yourself when you submit material to be posted to the site, for instance via the Messenger service or for forums or other interactive elements of the site. Please take care when doing so.

#### Information collected automatically

We do automatically collect certain non-personally identifiable information when you visit our site - such as the type of browser you are using, the type of device or operating system you are using and the domain name of your Internet service, unique device identifiers, your mobile device’s general geographic location, the words you have searched on or looked up, the ads you have clicked on visited, sections of the site visited, and duration of stay at the site. Such information in itself does not identify as in individual.

### 3. How We Use Information We Collect

We use non-personally identifiable information to:

- Review site usage, e.g. information on which pages are more popular than others, which allows us to improve the design, functionality and content of our site.

- Administer and facilitate your registration, log in and to provide you with the personalized features and the particular site service(s) for which that registration was necessary.
- Provide customer support or respond to your specific inquiry or to administer the relevant site activity to which it relates
- Provide and improve our services
- Troubleshooting and maintenance of our Site.
- Send notifications about offers and/or updates in connection with our Services or to supply information or goods you have requested.

When you provide your registration application, and in some cases when you supply personally identifiable information directly to us from certain parts of the Site, we may provide you with the opportunity to opt-in to certain uses, e.g. to provide you with information about the site or other services that you may find of interest. We will only share your personally identifiable information with anyone else for marketing purposes if you have specifically consented to that. Remember that you can opt-out of these again at any time - see Your rights below at clause 6 of this Policy.

We may also share this information with our current or potential commercial partners, for example investors, sponsors and advertisers for the Site.

If you reside in the EEA personal information you provide to us will not be transferred to other countries, including the United States, the data protection laws of which may differ from those of the European Union, unless you expressly agree to such transfer.

Please be aware that it is possible, though unlikely, that we might be forced to disclose personally identifiable information in response to legal process or when we believe in good faith that the law requires it, e.g. in response to a court order or a law enforcement agency's request.

#### **4. Cookies**

Our Site uses cookies. A cookie is a string of text information that a website transfers to the cookie file of the browser on a user's computer hard disk so that the website can remember who the user is. They are not programs, and cannot harm your device. A cookie will typically contain the name of the domain from which the cookie has come, the 'lifetime' of the cookie, and a value, usually a randomly generated unique number. When you visit our site we send you a cookie. Cookies may be used in the following ways:

- (a) To enable the personalization features on our site, which give you the ability to recall recently viewed pages and see information which you have provided online.

- (b) To compile anonymous, aggregated statistics that allow us to understand how users use our site and to help us improve the structure of our site. We cannot identify you personally in this way.
- (c) Two types of cookies may be used on this site, session cookies, which are: temporary cookies that remain in the cookie file of your browser until you leave the site, (ii) and persistent cookies, which remain in the cookie file of your browser for much longer, though how long will depend on the lifetime of the specific cookie.

You have the ability to accept or decline cookies by modifying the settings in your browser. To control or delete cookies, please visit the relevant settings of your browser. Please note, however, that blocking or declining all cookies may affect quality and functionality of the Site and You may not be able to use all the interactive features of our site if cookies are disabled.

## **5. Our Commitment to Security**

We employ appropriate technical and organizational security measures to prevent unauthorized access to information that we collect online.

## **6. Your Rights**

You may have the option to access, review, modify or erase certain information we collect from you and you have the ability at any time to request that we:

- (a) provide a copy of the personal information we hold relating to you (and we may make a small charge for this);
- (b) Update or remove any such personal information; and
- (c) Stop contacting you where we do this in accordance with your previous consent.
